Komisi Pengawas Persaingan Usaha (KPPU) menerima informasi kegiatan dan undangan dari *The Organisation for Economic Cooperation and Development/Korea Policy Centre* (OECD/KPC) untuk *the* 15th OECD/KPC *Competition Law Seminar for Asia-Pacific Judges in Cooperation with the Supreme Court and Judicial Academy of the Philippines* yang akan diselenggarakan pada tanggal 29 - 30 Mei 2025 di Manila, Filipina. Seminar ini diperuntukan untuk para Hakim dan Anggota Pengadilan serta tribunal persaingan usaha yang menangani perkara di bidang hukum persaingan dari kawasan Asia-Pasifik.

Seminar akan membahas pemahaman dasar mengenai standar pembuktian dan beban pembuktian, dengan menekankan pada dua aspek utama, beban hukum pembuktian dan beban pembuktian secara evidensial. Seminar ini bertujuan untuk memberikan pemahaman yang komprehensif kepada para hakim terkait aturan-aturan spesifik tentang standar dan beban pembuktian yang diterapkan di berbagai yurisdiksi. Para peserta akan terlibat dalam latihan berbasis studi kasus hipotetis, sesi tanya jawab dengan para ahli, serta diskusi berbagi pengalaman. Kegiatan ini dirancang untuk mendorong kerja sama dan memperluas jejaring antarpeserta di kawasan Asia-Pasifik.

Panitia mengusulkan peserta kegiatan merupakan hakim yang berpengalaman minimal 5 tahun, khususnya dalam menangani isu hukum persaingan usaha. About this seminar

Following fourteen successful events since 2011, the OECD/Korea Policy Centre Competition Programme is pleased to be holding its fifteenth annual seminar for judges in Asia-Pacific. This year the topic is "The Standard and Burden of Proof in Competition Cases".

The increasing complexity of competition law enforcement has raised important questions about the challenges faced by competition agencies when proving their cases and courts when reviewing the cases.

This question arises from a variety of factors. The growing complexity of cases and the increasing reliance on complex economic analysis to explain market dynamics and potential harm has certainly made competition cases harder to prove. The "more economics" or effects-based approach might have also impacted on the analysis that competition authorities have to go through when building their cases. In addition, economic theories are not always easy to translate into persuasive legal arguments, and yet judges are often asked to grapple with complex economic evidence and asked to turn economic theories into solid legal requirements.

Competition cases are subject to a robust judicial scrutiny, with courts often requiring a high level of evidentiary standard before finding (or confirming) a violation) or blocking a merger. This means that even when having a solid case, authorities may still fall short of satisfying the court's evidentiary standards.



Competition authorities are aware of this detailed judicial scrutiny and build their cases in a more thorough and careful way to withstand legal challenges.

The seminar will address fundamental notions of what is meant by the standard of proof and the burden of proof, distinguishing between its two aspects: the legal burden of proof and the evidential burden. This training aims at familiarizing judges with the specific rules on the standard and burden of proof adopted across jurisdictions.

Participants will be engaged on hypothetical case exercises and in Q&A sessions with the experts and will be actively involved through experience sharing moments to promote cooperation and networking among them. There will be opportunities for participating judges to ask questions, discuss issues of interest with the experts and share their own experiences.

The Seminar will be conducted in English. A draft agenda is attached to this invitation.

About the OECD/Korea Policy Centre


